TOWN OF WEDDINGTON SPECIAL TOWN COUNCIL MEETING FRIDAY, OCTOBER 15, 2010 - 3:00 P.M. MINUTES

The Town Council of the Town of Weddington, North Carolina, met in a Special Session at the Weddington Town Hall, 1924 Weddington Road, Weddington, NC 28104 on October 15, 2010, at 3:00 p.m. with Mayor Nancy D. Anderson presiding.

<u>Item No. 1. Open the Meeting.</u> Mayor Nancy D. Anderson called the October 15, 2010 Special Town Council Meeting to order at 3:02 p.m.

Item No. 2. Consideration of Developing Policy Regarding Town Appointments to Boards and Committees. Councilmember Robert Gilmartin and Mayor Pro Tem Daniel Barry volunteered to work with staff on developing a policy regarding Town appointments to Boards and Committees. Councilmember McKee asked that they also discuss the possibility of reducing the number of people serving on the Downtown Development Committee. The Downtown Development Committee currently has seven members due to vacancies but the total membership of the committee is 11. Councilmember McKee recommended that the committee's membership be changed from 11 to 7 since the downtown study has been completed and now the projects are smaller in nature.

<u>Item No. 3. Discussion and Consideration of Amending Recent Public Safety Appointments.</u> Mayor Anderson advised that one of the members that was appointed to the Public Safety Committee is not a Town resident; however, this person is a strong volunteer and sits on the Providence VFD Board of Directors and questioned whether the Town Council would like to appoint someone else in this position?

Councilmember Thomisser felt that individuals that did not live in the Town should not be excluded from volunteering on a Board or Committee if they have demonstrated that they want to make Weddington better and have shown to work very hard for the Town.

Councilmember Gilmartin and Mayor Pro Tem Barry will also work on developing a policy regarding whether individuals must live in the Town to serve on a Board or Committee.

Item No. 4. Discussion and Consideration of Amendments to the Temporary Driveway Easement Agreement between the Town of Weddington and Weddington Associates. Council was advised that there is a sewer easement agreement between the Town and Weddington United Methodist Church that will need to be amended because of the construction of the temporary driveway easement on Town Hall property. The sewer line for the parsonage will need to be rerouted during this process.

Mayor Pro Tem Barry moved to amend the sewer easement with Weddington United Methodist Church with the expense of rerouting the easement and legal fees to be paid by Weddington Associates. The easement will be moved outside of the road right of way and a stub to the line will be provided to the

Town. Council requested that language be added that the easement could be realigned in the future if needed.

All were in favor, with votes recorded as follows:
