

**TOWN OF WEDDINGTON

The Parks and Recreation Advisory Board of the Town of Weddington, North Carolina, met in a Special Session in the Town Hall Council Chambers, 1924 Weddington Road, Weddington, NC 28104 on Thursday, March 29, 2012, at 6:00 p.m. with Chairman Barbara Harrison presiding.

**Item No. 1. Open the Meeting.** Chairman Barbara Harrison called the March 29, 2012 Special Parks and Recreation Advisory Board Meeting to order at 6:06 p.m.

**Item No. 3. Approval of Minutes.**

**A. February 27, 2012 Regular Parks and Recreation Advisory Board Meeting Minutes.** Ms. Jean Lee Pirkey moved to approve the February 27, 2012 Regular Parks and Recreation Advisory Board Meeting Minutes. Ms. Gail Giattino seconded the motion, with votes recorded as follows:

**Item No. 4. Discussion of March 31, 2012 2<sup>nd</sup> Annual Easter Egg Hunt.** Chairman Harrison reviewed details regarding the 2<sup>nd</sup> Annual Easter Egg Hunt to be held on Saturday. She reported how many sponsorships she has received, gave specifics on the total of cash and in-kind donations and mentioned who would be in attendance to help volunteer. Ms. Pirkey is working on games for the event and will work with Ms. Pamela Hadley on technology needs. Chairman Harrison advised that there are approximately 2,000 stuffed eggs and that each child in attendance should be able to get 10 eggs each. She discussed how the prizes would be given out. Children will be able to have their picture made with the Easter Bunny, Harris Teeter's Harry the Dragon and the Chick-fil-A Cow. Committee members were asked to be at the Town Hall at 12:00 to help set up for the event. A formal update to the Town Council will be given at their meeting in May.

**Item No. 5. Discussion of April 21, 2012 Litter Sweep.** Chairman Harrison discussed the Spring Litter Sweep to be held on April 21 at 9:00 a.m. at the Town Hall. She advised that she will put out the "Litter Man" sign in the yard next week. Ms. McCollum advised that the Town has bags and vests for the event and she will handle getting the food. Town Staff will deliver flyers to the local businesses, Marvin Ridge and Weddington High Schools and will email the flyer to the HOA Presidents, newspapers, Town organization list, etc.

**Item No. 6. Discussion of Town Festival.** Chairman Harrison gave an update on meetings she has held with the surrounding communities on a joint festival. Ms. Harrison reported that at this time Wesley

Chapel and Waxhaw are not planning to participate; however, Marvin and the Waxhaw Arts Council were very interested. The Board discussed possible plans, themes, names and dates for a future festival.
