

**TOWN OF WEDDINGTON
REGULAR HISTORIC PRESERVATION COMMISSION MEETING

The Historic Preservation Commission of the Town of Weddington, North Carolina, met in a Regular Session in the Town Hall Council Chambers, 1924 Weddington Road, Weddington, NC 28104 on April 25, 2011, with Chairman Janice Propst presiding.

Item No. 1. Open the Meeting. Chairman Janice Propst called the April 25, 2011 Regular Historic Preservation Commission Meeting to order at 9:20 p.m.

A. Weddington Historic Tea. Chairman Propst advised the Commission that invitations were being mailed for the Town's 1st Annual Tea which is being sponsored by the Historic Preservation Commission. The Tea is scheduled for May 13, 2011 from 2 to 4 at the Town Hall. Individuals, whose families have been in Weddington for 100+ years are being invited to the tea to share family stories, pictures, articles and memorabilia to help preserve what makes Weddington unique. Chairman Propst advised that future teas would be held but that the first tea could only accommodate approximately 30 people to allow time for individuals to share family history and documents.

Chairman Propst also shared a picture that she had copied of the original Weddington Academy. Chairman Propst is going to frame the picture and start hanging these historical photographs in the Town Hall.

Chairman Propst informed the Commission that she is looking into the tenant house that is currently on the property owned by the Woods Development to determine whether the house could be salvaged as part of the Town's history.
